PURPOSE: Alive PPE Disposable Double Set is a protective clothing with limited life, Class 1 protection

Disposable Double Set manufactured and designed for use to prevent the transmission of infective agents between clinical staff and patients during surgical and other invasive procedures.

It is approved that the product fulfils all essential requirements and related rules of 9342/EEC Medical Devices Directive (MDD) Class 1 are applied.

LIMITATIONS:

Exposure to certain Chemicals or high concentrations may require higher protective properties through the material or construction properties of the Disposable Double Set. The user will be the only one to assess compliance with the required type of protection and proper connection of the süit with additional protective equipment.

METHOD OF PUTTING ON AND USING THE NON-STERIL DISPOSABLE DOUBLE SET:

Before use, check that the selected product is suitable for the existing hazard and in the correct size.

Remove the disposable double set from the packaging.

Check visually that the disposable double set is intact (no piercing, no torn seams, etc.)

Wear the upper garment first, then the lower garment without touching anything.

WARNINGS:

The Disposable Double Set is intended for single use and should be discarded after use Accepted configuration cannot be modified or changed.

If tears, punetures etc. occur, immediately leave the workplace and put on a new Disposable Double Set Do not remove the Disposable Double Set if the user is still in the danger area

Disposable Double Set with electrostatic properties must not be opened or removed when in a potentially explosive or flammable atmosphere or carrying explosive, flammable substances.

To provide complete protection, all openings should be closed/sealed. Extended wearing of Disposable Double Set can cause heat stress.

Overheating and discomfort can be reduced or eliminated by using appropriate undergarments or

appropriate ventilation equipment.

The product is flammable - keep away from fire.

TRANSPORT, STORAGE AND DISPOSAL:

The product must be transported and stored in the original packaging in dry rooms away from sources of light and heat. If the suits are not contaminated, they can be disposed of with solid municipal waste. If they have been contaminated, they must be disposed of in accordance with applicable lawsand regulations.
